GENERAL CONDITIONS OF OUR BUSINESS

DEPOSITS: Two cheques must accompany your rental payment 30 days in advance of your arrival: one, for 150 euros as ? Locatif and the other, for 50 euros to cover possible cleaning expenses. These will NOT be cashed by us, but returned to you on the day of your departure, minus any deductions made for lost or damaged property, of the cost of cleaning, if necessary. If your departure takes place outside the opening hours of our Office (before 8 a.m. or after 8 p.m.) these deposit cheques will be returned to you by post within 30 days.

RECEPTION: All our clients must without fail report to the Reception Office of the camp-ground to sign in and pay the relevant charges.

SWIMMING POOL: Only bathing-wear is permitted in the swimming pool. Bermuda shorts etc are not permitted. Access is allowed only to residents of the camp-ground. Children must be accompanied by their parents. The pool is open from March to November if weather conditions permit. It is heated during this same period.

ARRIVALS AND DEPARTURES: these must take place on SATURDAY during July and August. At other times of the year they can be on the day of your choice. The rental sites are available from 4 o'clock till 8 o'clock, and they must be vacated by 10 a.m. In the absence of a message sent by post, e-mail or fax stating that you wish to change the date of your arrival, the camp-site or cabin becomes available for re-letting from 8 a.m. on the day after the date of arrival agreed upon in the rental contract and the entire payment for this service is forfeit. No reduction, reimbursement or transfer will be made in the case of delayed arrival or unforeseen departure, for any reason whatsoever. Every rental-period, once entered into, must be paid for in its entirety.

CANCELLATION: If you have to cancel your booking before the 30th day prior to the agreed arrival date, a deduction of 40 euros will be made from your deposit, prior to repayment. After that date, the whole payment will be retained, except in case of the following reasons for cancellation offered with documentary evidence: accident; illness or decease of husband/wife/family or close relatives.

Special circumstance for CANCELLATION If one of the following events intervenes between the day of signing the rental agreement and the day of your arrival your payment will be reimbursed, except for a forfeit of 40 euros, on presentation of documentary evidence: accident; illness; decease of the renting party, his/her wife/partner, close family or children; serious reason necessitating the immediate departure of the renting party, such as a theft, fire or natural disaster involving the residence of the renting party, or redundancy/dismissal from employment of the renting party and/or his/her partner.

ANIMALS: Dogs of the 3rd category are permitted, on presentation of vaccination certificates, for stays in caravans, camping-cars and in our rental spaces, on condition that they be kept on a leash and not left alone in the camp-ground. Dogs are not permitted to be kept in tents. Cats are permitted. No other animals are allowed.

RESPONSIBILITY: The Company declines all responsibility for errors, omissions or consequences. Information from hyper-text links, which could lead to the site www.complaves.com from other web-sites. The information contained in our site (practical and cultural information) may contain errors for which the company can in no case be held responsible. The photographs which appear on our site are not contractual, we remain free to choose other images and to offer other types of rental accommodation, even though we maintain our commitment to maintaining the quality of our service. In the event of litigation against the Company only French law will be applicable, and only the Tribunal de Commerce of Toulon (Var, France) will be dealt with. In the case of differing interpretations and contradictions, only the written French law will be honoured.

DURING YOUR STAY: You must respect the rules. Our Company can in no case be responsible for the loss or theft of personal objects; or injuries and damage that could occur to holiday-makers and their belongings. For reasons of security and insurance it is forbidden to exceed the number of occupants designated for each form of rental accommodation.

BARBECUES: Only electric barbecues are permitted, and only outside the rental accommodations. (Remember bring an electrical extension-cord.)

SMOKERS: We would appreciate it if you did NOT smoke inside our buildings. We thank you for your understanding.

Each tenant is expected to conform to the rules of the camp-ground, and to the particular conditions displayed at the entrance; and acknowledge that the fact of staying here implies acceptance of these rules and willingness to abide by them.
